WHO CAN JOIN?

Membership of AustCham South China is open to individuals and companies. AustCham South China's Board of Directors reserves the right to decide the appropriate membership category for each applicant. The Membership categories are:

Foundation Membership (2 years)

Membership under this category is open to Australian, Chinese or international corporation, enterprises or institutions. Foundation Membership is the 2 years premium level of AustCham South China and includes the same benefits as corporate membership, along with additional 'naming rights' and elite organizational branding and services. For more information on a custom Foundation Membership please contact the AustCham office. The annual Foundation Membership fee is RMB 30,000.

Platinum Partnership (1 year)

Platinum Partnership is open to Australian, Chinese or international corporation, enterprises or institutions offering valuable in-kind services. Partnership includes the same benefits as corporate membership, along with additional 'naming rights' and elite organizational branding and services. The annual Platinum Partnership fee is in-kind services to the value of RMB 30,000.

National Corporate Membership (1 year)

National Corporate membership is open to corporations, enterprises or institutions that have a registered office in China with Australian, Chinese or international ownership, management and interests. National Corporate Membership include benefits from AustCham – Beijing, West China and South China. The annual membership fee is RMB 15,000.

Exclusive Hotel Membership (1 year)

Exclusive Hotel membership is open to 5-star hotels within China, in the cities that AustCham South China hosts events. This membership will be strategically approved based on an established quotation of event services when applying. This will guarantee Exclusive Hotels a series of preset events throughout the year. The annual Exclusive Hotel fee is RMB 10,000.

Corporate Membership (1 year)

Corporate membership is open to corporations, enterprises or institutions that have a registered office in China with Australian, Chinese or international ownership, management and interests. The annual membership fee is RMB 4,000.

Individual Membership (1 year)

Individual membership is open to any Australian citizen, or permanent resident of Australia, or any person of another nationality with a substantial affiliation with or interest in Australia, who subscribes to the mission and objects of the Chamber. The annual membership fee is RMB 1,000.

Young Professional (1 year)

Young Professional membership is open to individuals ages between 18 – 28 any Australian citizen, or permanent resident of Australia, or any person of another nationality with a substantial affiliation with or interest in Australia, who subscribes to the mission and objects of the Chamber. The annual membership fee is RMB 800.
